<p>We will keep your data for:</p>	
<ul style="list-style-type: none"> • The Group will retain personal data for no longer than is necessary to fulfil contractual and regulatory obligations in line with our Retention Schedule. • We will keep your data for seven years. • We will destroy your data via a confidential waste service at the end of the retention period. 	
<p>You have the right:</p>	
<ul style="list-style-type: none"> • To be informed – about the personal data we process about you. • Of access – have copies to your data, within one calendar month of your written or verbal request. • To rectification – have your data amended if the details are incorrect/incomplete. • To erasure – have your data deleted, in certain circumstances. ** 	

- To restrict processing – ask us to restrict the processing of your data, in certain circumstances. **
- To object to processing – if we process your data because it forms part of our public tasks or is in our legitimate interests. **

**If you withdraw your consent or ask us to limit processing of your data, please be aware that we will not be able to fulfil our contractual agreement with you.
